REQUIRMENTS:

- Site for field experience must be approved by Mr. Carreiro prior to hours being completed
- Students must complete the field experience paperwork and presentation by May 1st of the graduating year.
- Completion of the field experience is a requirement to graduate the Institute

START DATE: Students may begin the field experience as early as the summer after their Junior (11th grade) year. However, students planning to complete the field experience during the summer must get prior approval by Mr. Carreiro no later than May 20, 2016.
